Jean-Thomas Arrighi is Senior Lecturer in the Department of History at the University of Neuchâtel, Switzerland and Associate Researcher at the National Centre of Competence in Research (NCCR) – On the Move (Switzerland).

Lisa Marie Borrelli is a postdoctoral researcher within the NCCR – On the Move at the HES-SO Valais, Institute of Social Work, Sierre and lecturer at Neuchâtel University, Laboratory for the Study of Social Processes in Switzerland. In her work she is interested in organizational sociology, qualitative methods and migration studies. She is particularly interested in the entanglements of (non-)bureaucratic actors within the migration regime, discretionary spaces and street-level bureaucracy, which she examines through a socio-legal analysis and ethnography. He obtained his PhD at the University of Illinois at Urbana-Champaign, USA. His research explores cross-nationally the micro- and macro-level determinants of attitudes toward immigrants and immigration in Europe, the link between anti-immigrant sentiment and national feelings, perceptions of immigrants' impact on crime, and public support for democracy in Latin America.

Manlio Cinalli is Professor of Sociology at the University of Milan, Italy, and Associate Research Director at Sciences Po, Paris, France. He has taught and conducted research in various universities and institutes across Europe and the US. He has published widely on political integration, citizenship, migration, exclusions and cultural cleavages.

Xavier Escandell is the Director of the Data Analysis and Social Inquiry Lab (DASIL) and Associate Professor, in the Department of Anthropology, at Grinnell College, USA. He obtained his PhD at the University of Illinois, Urbana-Champaign, USA, and was a pre-doctoral fellow at the University of California San Diego, USA, in the Center for Comparative Immigration Studies. Fiorenza Gamba is a Professor in Sociology of Culture and Communication at the University of Sassari, Italy, and affiliate researcher at the Institut de Recherches Sociologiques (IRS) at the University of Geneva, Switzerland. She studied philosophy at the University of Turin, Italy, and at the University Paris 4 – Sorbonne, France. She holds a PhD in Philosophy (Sorbonne) and a PhD in Sociology (Turin) and obtained her habilitation in Anthropology and Sociology at the University of Strasbourg, France. James F. Hollifield is Professor of Political Science, Arnold Chair in International Political Economy, and Director of the Tower Center, Southern Methodist University (SMU), USA.

A member of the Council on Foreign Relations and Global Fellow at the Woodrow Wilson International Center, USA, he has worked as a consultant on migration and development for governments and international organizations and has published widely on international political and economic issues, including *Immigrants, Markets and States* (Harvard University Press), *Migration Theory* (Routledge) and *Controlling Immigration* (Stanford University Press). His current book projects include *Understanding Global Migration* (Stanford University Press) and *International Political Economy: History, Theory and Policy* (Cambridge University Press).

David Jacobson is Professor of Sociology at the University of South Florida, USA, and Professor Emeritus of Global Studies and Sociology at Arizona State University, USA. Born in South Africa, he received his graduate training at the London School of Economics, UK and Princeton University, USA. Professor Jacobson is the author of *Rights Across Borders: Immigration and the Decline of Citizenship*, one of the foundational books on postnationalism and citizenship; *Of Virgins and Martyrs: Women and Sexuality in Global Conflict*; and *Place and Belonging in America*, all published by the Johns Hopkins University Press. He has had visiting appointments at the Peace Research Institute Oslo (PRIO), Norway; Sciences Po, Paris, France; Copenhagen Peace Research Institute, Denmark; and the Leonard Davis Institute of International Relations, Israel.

Thomas Janoski is Professor of Sociology at the University of Kentucky, USA, and former director of the Quantitative Initiative in Political and Social Research. He has also taught at the University of California–Berkeley and Duke University, USA. He is the author of *Citizenship and Civil Society* (1998), *The Ironies of Citizenship: Naturalization Policies in Industrialized Countries* (2010), *The Structural Causes of Unemployment* (2014), and *Strategies of Success among African Americans and Afro-Caribbeans* (2018). He has co-edited four edited volumes, of which the most recent are *The New Handbook of Political Sociology* (2020) and *The International Handbook of Lean Production* (2021).

Edward Koning is Associate Professor of Political Science at the University of Guelph (Ontario, Canada). Most of his research investigates the politics of immigration in Western democracies, specifically regarding immigrants' social rights and the role of populist anti-immigrant parties. He is the author of *Immigration and the Politics of Welfare Exclusion* (University of Toronto Press, 2019), and has published in leading academic journals (including *Comparative European Politics*, *Comparative Political Studies*, *Ethnic and Racial Studies* and *Journal of Public Policy*) on a variety of related issues, including anti-immigrant politics, institutionalist theory, public opinion on immigration, and citizenship policy.

Stefanie Kurt holds the position of Assistant Professor (Tenure Track) at the HES-SO Valais, School of Social Work in Siders (Switzerland). She completed a Master of Law degree in International and European Law from the University of Bern and a PhD in Law from the University of Neuchâtel, Switzerland. Her research interests focus on migration law, integration and citizenship.

Laurence Lessard-Phillips is a Senior Research Fellow at Institute for Research into Superdiversity (IRiS), in the School of Social Policy at the University of Birmingham, UK. Didier Ruedin (DPhil, Oxford) is a senior researcher at the University of Neuchâtel, Switzerland, and a research associate at the University of the Witwatersrand, South Africa. He uses experiments and quantitative analysis to study social inequalities and reactions to them, especially in the field of immigration and ethnic minority groups. His research examines social inequalities through ethnic discrimination, politicization, public policies and attitudes. Recent studies have examined discrimination in the labour and the housing market, attitudes to foreigners, and political reactions in policies and political debates: how, when and why potential conflicts become politicized.

Shamit Saggat is the Director of the Public Policy Institute and Professor of Public Policy

at the University of Western Australia. He was previously a Senior Policy Advisor in the Prime Minister's Strategy Unit, UK Cabinet Office; an Economic and Social Research Council (ESRC) Knowledge Exchange Fellow with HM Government, UK; Associate Pro-Vice-Chancellor (Research) at the University of Essex, UK; Professor of Political Science, University of Sussex, UK; Reader in Political Behaviour at Queen Mary, University of London, UK; Harkness Fellow at the University of California, Los Angeles (UCLA), USA; Yale World Fellow at Yale University, USA; and Visiting Professor of Public Policy at the University of Toronto, Canada. In 2015 he was elected as a Fellow of Academy of Social Sciences, UK; and in 2017 became Chair of the Campaign for Social Science. In 2017 he was awarded a CBE in the Queen's Birthday Honours for services to social science and public policy.

Daiva Stasiulis is Chancellor's Professor of Sociology at Carleton University, Canada. Growing up in an immigrant household of parents who arrived as displaced persons from the Baltic Republics helped to shape her research interests. These include Canada's settler colonial and migration history, temporary workers, migrant domestic labour, anti-racism, the nexus between citizenship and migration, statelessness and feminist intersectional theory. Her books include *Unsettling Settler Societies: Articulations of Gender, Race, Ethnicity and Class* (edited with N. Yuval-Davis), *Negotiating Citizenship: Migrant Women in Canada and the Global System* (with A. Bakan), and *Gender and Multiculturalism: North-South Perspectives* (edited with A. Gouws).

Oliver Strijbis is Swiss National Science Foundation (SNSF) Professor at the Institute of Political Science of the University of Zurich, Switzerland, and an associated researcher at the German Institute of Global and Area Studies (GIGA). Mr Strijbis is an editor of *The Struggle over Borders: Cosmopolitanism and Communitarianism* (Cambridge University Press) and has published in the *European Journal of Political Research*, *Electoral Studies*, *Sociological Methods and Research*, *International Journal of Forecasting* and *Party Politics*, among others.

Thijl Sunier is Emeritus Professor of Cultural Anthropology, Chair 'Islam in European Societies' at the Vrije Universiteit Amsterdam, the Netherlands, researching on Islamic authority, religious critique, leadership and knowledge production in Europe. Currently he is involved in a European Union-funded research project 'Mediating Islam in the Digital Age' (MIDA). His latest English-language book is *Islam and Society, Critical Concepts in Sociology* (four edited volumes, 2018, Routledge). In preparation is *The Anthropology of Islamic Authority* (Brill). He is Chairman of the Board of the Netherlands Inter-University School for Islamic Studies (NISIS) and Executive Editor of the *Journal of Muslims in Europe* (JOME/Brill).

Daniela Vintila is lead postdoctoral researcher in the European Research Council (ERC)-funded project 'Migration and Transnational Social Protection in (Post)Crisis Europe' at the Centre for Ethnic and Migration Studies (CEDEM) of the University of Liège, Belgium. She holds a PhD in Political Science from Universidad Autónoma de Madrid, Spain. Her research interests lie in the areas of comparative politics, citizenship, European Union studies and international migration. She is chair of the European Consortium for Political Research (ECPR) Standing Group Migration and Ethnicity, vice-chair of the International Political Science Association (IPSA) Research Committee European Unification, and co-convenor of

the International Migration, Integration and Social Cohesion in Europe (IMISCOE) Standing Committee Migration, Citizenship and Political Participation.

Rens Vliegthart is a Professor for Media and Society at the Amsterdam School of Communication Research (ASCoR), University of Amsterdam, the Netherlands. He is also the Scientific Director of ASCoR. His research focuses on the coverage of contested political issues in media, and the effects of this coverage on policy and public opinion. His work has appeared in a wide range of journals in political science, communication science and sociology.

Catherine Wihtol de Wenden is an Emerita Director of research at the French National Centre for Scientific Research, CNRS (Sciences Po, CERI), France. As a specialist of migration with a political science and a legal background, she has studied many aspects of the relations between citizenship and migration at French, European and world levels. She has conducted many field researches, supervised 25 PhDs and she is the author of 25 books. The most recent are: *La question migratoire au XXIème siècle* (Paris, Presses de Sciences Po, 2017), *Faut-il ouvrir les frontières* (Paris, Presses de Sciences Po, 2017), *Atlas des migrations* (Paris, Autrement, 2018), *Géopolitique des migrations* (Paris, Eyrolles, 2019), *Un monde de migrations* (Paris, CNRS Editions, 2019) and *L'immigration: chance ou menace?* (Paris, First, 2020). She is also a co-author of *Policing the Inner Cities in France, the United Kingdom and the US* (Pivot, Palgrave, 2015, with Sophie Body-Gendrot). She is member of the scientific committee of the National Museum of immigration in Paris, and she teaches at Sciences Po Paris, France.

Maria Xenitidou studies identity and discourse. She uses discursive and rhetorical approaches to explore a range of topics, including identity, power, migration, citizenship, and intergroup relations. She has led projects on mobility and belonging, both at the University of Surrey, UK and at the University of Crete, Greece, and has worked in several research projects in the UK and Greece: ESRC, Marie-Curie, FP6, FP7, and Horizon 2020.
